

# Lifetime Glass Warranty



## Glass Breakage/Seal Failure:

Lindsay Windows, the manufacturer of the window(s) in your home, warrants that should the glass break, crack, or have a seal failure, as long as you the Original Purchaser/Property Owner shall live and own the property at the address listed herein. Lindsay shall provide a new seal glass unit at no charge delivered to your dealer. Installation and shipping are not covered and is the responsibility of the homeowner.

## Exclusions:

Coverage hereunder is limited to the Original Purchaser/Property Owner only and is not transferable to other owners. The standard window warranty, when property transferred, is available e to the new owner. Removal of the windows from the premises invalidates the Warranty. Acts of God (floods, earthquakes, fires and act of civil unrest, wars, riots, etc.) are not covered. Architectural (bent glass) garden window, special shapes and beveled or grooved glass are excluded. Windows that exceed Lindsay’s size limitations are excluded. Apartment buildings, condominiums, commercial buildings are also excluded from coverage. The provisions of the Warranty are the full and complete warranty policy extended by Lindsay. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitations for exclusions may not apply to you. This Warranty give you specific legal rights and you may also have other right which vary from state to state.

## Claims Procedure:

If the contractor or company that originally installed your windows is still available, please contact them to start your warranty claim. If not, please contact Lindsay Windows directly and we can help you. In order to fulfill your warranty, you do need to get the order/warranty number off the window warranty label. This label is found on the side of the sash or in the head of the window. The replacement glass will be shipped to your dealer or directly to you, dependent on the situation.
