Lifetime Glass Warranty

Glass Breakage/Seal failure:

Lindsay Windows, the manufacturer of the window(s) in your home, warrants that should the glass break, crack, or have a seal failure, for as long as you the Original Purchaser/Property Owner shall live and own the property at the address listed herein, Lindsay shall provide a new sealed glass unit at no charge delivered to your dealer. Installation is not covered and is the responsibility of the homeowner.

Exclusions:

Coverage hereunder is limited to the Original Purchaser/Property Owner only and is not transferable to other owners. The standard window warranty, when properly transferred, is available to the new owner. Removal of the windows from the premises invalidates the Warranty. Acts of God (floods, earthquakes, fires and act of civil unrest, wars, riots, etc.), are not covered. Architectural (bent glass) garden window, special shapes, and beveled or grooved glass are excluded. Windows that exceed Lindsay's size limitations are excluded. Apartment buildings, condominiums, commercial buildings are also excluded from coverage.

The provisions of the Warranty are the full and complete warranty policy extended by Lindsay.

THE WARRANTY STATEMENTS CONTAINED IN THIS LIMITED WARRANTY SET FORTH THE ONLY EXPRESS WARRANTIES EXTENDED BY LINDSAY FOR THE GLASS AND THE PROVISIONS HEREOF SHALL CONSTITUTE THE PROPERTY OWNER'S EXCLUSIVE REMEDY FOR BREACH OF THIS WARRANTY. LINDSAY SHALL NOT BE LIABLE TO THE PROPERTY OWNER FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY KIND FOR BREACH OF ANY EXPRESS OR IMPLIED WARRANTY ON THE GLASS.

Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitations or exclusions may not apply to you. This Warranty gives you specific legal rights and you may also have other rights which vary from state to state.

Claims Procedure:

Please submit your warranty claim in writing to Lindsay Windows, 1995 Commerce Lane, North Mankato, MN 56003. The claim must include proof of ownership, a copy of your original contract, proof of purchase and must contain the factory order number and window order number from the window warranty label. This label is found on the side of the sash or in the head of the window. Lindsay Windows reserves the right to inspect the glass if required. A reasonable time shall be allowed for such an inspection. The replacement glass will be shipped to your dealer.
